Option A; Taxpayers view for free Title Company's, Ect. get a \$2 charge Townships getting \$1 per charge at no cost to the Township. Option B; Township pays \$2000 for unlimited by all. Forwerck made motion to trial the Paper Hit Option, Sorrow 2nd. All in Favor, Motion Carried.

Ogur Questioned if tax payment can be paid via credit card in the future. Sorrow will check it out.

f. FLAUA - Bob Sturdevant turned in his resignation as FLAUA Board Member.

Ogur made Motion to appoint Brandon Quizdala to FLAUA Board as citizen representative for Fife Lake Township. Sorrow 2nd. All in Favor, Motion Carried.
