

# **FIFE LAKE TOWNSHIP BOARD**

## **SPECIAL MEETING**

**January 15, 2015**

### **DRAFT/APPROVED**

Fife Lake Township Board Special Meeting was called to Order a 4 pm starting with the Pledge of Allegiance.

Roll Call: Street - [Here](#), Sorrow – [Here](#), Forwerck – [Here](#), Ogur – [Here](#), Rognlie – [Here](#).

Also Present – Deputy Mike Hornacek

Public Comment - None

Approval of Agenda – As there was a full Board present, Ogur added 7A. She would like to make a statement. Then made the motion to approve the Agenda with addition. Sorrow second. All in favor, Motion Carried.

Clarification of November 20, Minutes:

William Fisk, President of FLAUA Board, pointed out there was no vote on a first and seconded motion placing Linda Forwerck on FLAUA as an alternate board member. Fisk was concerned that it may make Linda's' FLAUA member's motions and votes null. By MTA guidance the minutes were accepted as stated after the December meeting when the November minutes were unanimously accepted. Therefore the minutes were approved as written with final action of board approving the appointment.

Ogur stated that to avoid any confusion we should repeat the action of appointing Forwerck as an alternate. Ogur made a motion to appoint Forwerck as an Alternate Member of the FLAUA Board retroactive to November 20, 2014. Sorrow seconded.

Discussion

Roll Call Vote Finds; Street – Yes, Sorrow – Yes, Forwerck – Yes – Ogur – Yes, Rognlie – No. 4 – Yes, 1- No, Motion Carried.

Ogur asked to make a statement and explained that it is sometimes difficult as a board member to keep personal feelings and professional feelings separate and that she always strives to make decisions that she feels are best for the township citizens. Ogur stated that she feels that Rognlie seems to be making decisions based on personal feelings as well as personal vendettas and asked Rognlie to consider resigning from the township board. Ogur made a motion to remove Rognlie from the FLAUA Board. Sorrow seconded,

Discussion; Ogur stated that due to Rognlies' bullying tactics that many people have resigned from boards that Rognlie has served on and that the township is having difficulties filling open positions on boards due to Rognlies' lack of team work.

Rognlie expressed her frustration with the board in general with the actions that they have taken to try to remove her from all boards and committees. She stated that she feels that she works well with others and has never lost her cool.

Street stated to Rognlie that this may be a good time for personal reflection.

A brief discussion continued where Rognlie again expressed her frustration with the board and she pointed out that the township board does not have the right to remove her from FLAUA and she read a portion of the FLAUA bylaws.

Forwerk stated that a motion was made and passed by the board and that this action would remain in effect. Forwerk also stated that she would contact our attorney to review this issue.

Ogur made motion to appoint Forwerck as full time FLAUA Board Member, replacing Rognlie, Sorrow seconded.

4 – Yes, 1- No. Motion Carried.
