Resolution No. 2026.02.01 - Dissolution of the Fife Lake Area Planning Commission

On February 26, 2026, the Fife Lake Township Board adopted Resolution No. 2026.02.01 formally removing the Village of Fife Lake from the Fife Lake Area Planning Commission. As a result of this action, the Fife Lake Area Planning Commission was effectively dissolved as of February 26, 2026.

Ordinance No. 2026.02.03 - Establishment of the Fife Lake Township Planning Commission

On February 26, 2026, the Fife Lake Township Board adopted Ordinance No. 2026.02.03 re-establishing the Fife Lake Township Planning Commission pursuant to the Michigan Planning Enabling Act. Beginning February 26, 2026, all planning and zoning duties and responsibilities for Fife Lake Township shall fall under the jurisdiction of the Fife Lake Township Planning Commission in accordance with applicable township ordinances and the Michigan Zoning Enabling Act.
